G. POYSER IN THE CHAIR

NORDIC ECS CENTRE

Secretary-Treasurer Schulte informed Trustees that the Nordic ECS Centre is a private ECS group operating in a building owned by Battle River Regional Division #31 that is located west of New Norway School. This Centre has had a lease for the use of the building signed by the County of Camrose prior to regionalization, and that is now expiring. Mr. Schulte outlined the terms of the lease. F.A.N.S. (CAMROSE SMOKING BYLAW COALITION) INFORMATION DISPLAY

Acting Superintendent Phillips informed Trustees that a letter had been received from the Camrose Smoking Bylaw Coalition requesting permission to set up a display in Battle River Regional Division #31 schools in the Camrose area with respect to raising public awareness about the effects of environmental tobacco smoke. The purpose of the display is to provide information to students who may know a family member or friend that smokes and increase that student's knowledge about the dangers of smoking.

Trustees indicated that there would be no problem having this displayed in schools provided there is no political intent. This was received as information only.

Fraser Institute Awards

Acting Superintendent of Schools Phillips and Trustee Sears attended the third annual W. Garfield Weston Outstanding Principals Awards in Calgary on October 22, 2002.

Mr. Doug Bowie, Principal at Bawlf School, received the 'Academic Achievement in Excess of Expectations' award, and was a finalist in the 'Overall Academic Excellence' category. The 'Academic Achievement in Excess of Expectations' award recognizes the eligible principal whose school has achieved the highest overall academic performance relative to expectations (based on parents' average education in years) in the past three years. The 'Overall Academic Excellence' award recognizes the eligible principal whose school has achieved the highest overall academic performance for the past three years.

Mr. Rick Tews was a finalist in the 'Improvement in Academics' category. This award honors principals whose schools progressed most rapidly in overall academic performance during the most recent three-year period. This time frame would include the years Mr. Tews served as principal at Hay Lakes School.

BIG BROTHERS, BIG SISTERS PROGRAM

Dr. Phillips noted that representatives from the Big Brothers, Big Sisters Program presented a proposal to Mr. Stephen Smith, Acting Chief Deputy Superintendent of Schools. The program representatives proposed piloting a program at several schools in Battle River Regional Division #31 to work with students at noon and after school in a tutoring capacity. The students receiving tutoring would be those registered in the Big Brothers, Big Sisters program.

Student Affairs Committee

The Student Affairs Committee met on October 11, 2002 and upheld a recommendation for expulsion of a student. The student will be set up on a home schooling program.

Capital Plan Committee Update

Trustee Sears reported that the modernization work on the Forestburg School is proceeding well.

Chairman Poyser reviewed a letter from the Minister of Infrastructure with respect to the approval of two core portables at the Charlie Killam School. It was noted that several Trustees and administrators will be meeting with the Minister of Infrastructure, Ty Lund, on Tuesday, October 29, 2002.

Chairman Poyser reviewed a letter received from the ASBA with respect to the hiring of an independent person to review procedures related to the recent labor issues.
